Terms and Conditions

1. Introduction

- 1.1. These Terms and Conditions ("Terms") govern the provision of programming, electronics, and robotic workshops ("Services") by Robotton ("we" or "us") to children ("Attendee") aged 9 to 12 years old.
- 1.2 By enrolling a child in our workshops, you (the "Parent/Guardian") agree to be bound by these Terms.

2. Enrolment and Payment

- 2.1. Enrolment is confirmed upon receipt of the registration form and payment of the required fees for the school term.
- 2.2. Services run for up to 9 weeks per school term at a rate of \$690 per term. If a term is shorter than 9 weeks, as stated in the enrolment form, the fee will be calculated on a pro-rata basis.
- 2.3. Fees are non-refundable, except in cases of cancellation by us.
- 2.4. We reserve the right to adjust fees at any time.

3. Services

- 3.1. We will provide Services to Attendees, which include instruction and basic materials required to deliver the Services.
- 3.2. Parents/Guardians may be asked to purchase additional materials for special projects.
- 3.3 At the end of each term, Attendees collaborate on a group project showcasing their learning.
- 3.4. Attendees will handle low voltage batteries to power low to moderate energy consumption electronic components. Batteries used are 9V or lower, similar to those found in supermarkets and hardware stores.
- 3.5. We reserve the right to modify or cancel Services at any time at our discretion. Undelivered paid workshop sessions will be refunded.

4. Attendee Conduct

- 4.1. Attendees are expected to behave in a respectful and responsible manner and not interfere with the learning of other Attendees.
- 4.2. We reserve the right to dismiss any Attendee whose behaviour is deemed unacceptable or affecting learning of other Attendees.

5. Liability and Indemnity

- 5.1. We are not liable for any damage or injury caused by Attendees during Services.
- 5.2. Parents/Guardians indemnify us against any claims, damages, or expenses arising from their child(ren) participation in Services.

6. Intellectual Property

- 6.1. All intellectual property rights in materials, methodologies, or proprietary project designs provided by us remain our property ('Intellectual Property' or 'Project Artefacts').
- 6.2. Attendees and Parents/Guardians may not reproduce, distribute, or display any Project Artefacts without our prior written consent.

7. Personal Information

- 7.1. We collect personal information from Parents/Guardians and Attendees for the purpose of providing Services.
- 7.2. We will handle personal information in accordance with our Privacy Policy.

8. Governing Law

- 8.1. These Terms are governed by and construed in accordance with the laws of New Zealand.
- 8.2. Any disputes arising from these Terms will first be attempted to be resolved through mediation with FairWay Resolution. If mediation fails, the dispute may proceed to arbitration or another legal remedy as agreed by both parties.

9. Changes to Terms

- 9.1. We may modify these Terms at any time.
- 9.2. Changes will be effective immediately upon publication on our website, robotton.co.nz.

10. Acceptance

10.1. By enrolling your child in our Services, you acknowledge that you have read, understood, and agree to be bound by these Terms.
